C. FRESH PROPOSALS:

1. CRZ clearance for "Water Sports Activities in the Puri Beach" by Nilachakra Water Sports Pvt. Ltd.

The Managing Director, Nilachakra Water Sports Pvt. Ltd., Chakratirtha Road, Nuasahi, Puri has submitted a proposal for CRZ clearance for "Water Sports Activities in Puri Beach".

The main objective of the proposed project is to provide water sports activity at Puri by private participation. It will also provide alternate livelihood to the local coastal fishermen community.

The Proposed project will provide following water sports facilities for the beach tourism at PuriBeach:

- (1) Jet skiing 4nos. 3 person capacity in each having 2 stroke & 700cc engine. The maximum speed is 60 km/hr
- (2) Speed boats 4nos. having 2 stroke 40hp OBM engine -6 persons capacity each
- (3) Bacardi Boat- 2nos. having 2 stroke 40hp OBM engine -10 persons capacity each
- (4) Bumper Tube 2nos inflatable Towable Tube-TORPEDO-2 model.
- (5) Banana Tube 2nos inflatable Towable Tube model

No construction is proposed in the proposal.

For all the operations, necessary safety provisions like jackets, crash helmet, first-aid kits, fire extinguisher and UHF/ GPS for communication will be provided.

The proponent is interested to operate the above water sports activity in the sea front from 19^{0} 48′ 1.5″ N & 85^{0} 50′ 46.4″E to 19^{0} 47′ 41.6″ E & 85^{0} 49′35.1″ E.

The proponent has provided a Disaster management plan, EIA report and a brief safety plan for the proposed water sport activity. However, the District Administration need to develop a comprehensive safety/ operational plan for beach water sports for the smooth operation in Puri Beach.

The cost of the proposed project is Rs. 96.0 lakhs.

The proposed water sport activity is planned to operate in the offshore area within 1 nautical mile, which is in CRZ-IV (A) (Sea water body) and utilise CRZ-I (B) (Intertidal area) for boarding and landing purpose.

The proposed activity is related to "water front" as it will operate above mentioned water sport craft / small vessels. Therefore, proposed water sport activity can be considered as permissible under para 3 (i) (a) "those directly related to water front or directly needing foreshore facilities" of CRZ Notification, 2011.

The proposed project does not attract Environmental Clearance under EIA Notification, 2006.

OCZMA may discuss the proposals and if considered, may grant CRZ clearance to the aforesaid projects as per the provision of CRZ Notification, 2011.

2. CRZ Clearance for Shamuka Beach Project, Puri by Dept. of Tourism & Culture

The Director Tourism & Additional Secretary to Govt. has submitted a proposal for CRZ clearance for "Shamuka Beach Project" at Puri.

Under the Chairmanship of the Commissioner-Cum- Secretary, Department of Tourism, Govt. of Odisha, decided to develop a project as Shamuka Beach Project at South of Puri alongside of Bay of Bengal.

The objectives of the proposed project is to provide a high end, business-cum-luxury tourism and unlocking the destination would offer the tourist an opportunity to feel and experience the rich culture, indigenous art & craft, customs and traditions of Orissa.

The Shamuka Beach project is proposed to develop in 3 phases.

Phase-I will include convention centre, hotels based on various national and international standards, heritage town with main street, golf course, water sports etc.

Phase-II includes Health and Wellness tourism focus and

Phase-III includes high end villas & second homes

The proposed project is located between Puri Town and Chilika lake alongside the Bay of Bengal. The Mangala River separates Puri Town from Shamuka Beach project. The selected site has 2000 meters sea front and 2000m River front on its adjacent side. The Proposed Shamuka beach project site is 8 km distance from Puri and 60km from Bhubaneswar. The site can be accessed through Puri- Brahmagiri road which is approximately 3 km away. There is a two lane road constructed by Odisha Industrial Infrastructure Development Corporation (IDCO) along side of the Puri- Brahmagiri road and the site. The geographical location of the proposed project area is as follows:

For the proposed Shamuka beach project 920.04 Ac. of land will be used. The land is acquired by IDCO and the lease deed was transferred in favour of Department of Tourism for 90 years. The land will be utilised as 80.07 Ac for institutional, 103.35 Ac. for commercial, 100.83 Ac. for Residential, 12.38 Ac. for utility & services, 198.56 Ac. for Open space & recreational , 128.13 Ac. for Mix Land use, 221.08 Ac. for Golf Course and 75.65 Ac. for Roads . The total construction /built up area is 916046 sq.m.

The total cost of the project is Rs. 166.67 Cr.

The water requirement for the project is 14 MLD. The water for this project shall be provided from the water supply project of Puri Township from JNNURM Norms. The electricity requirement is 45 MW, which will be sourced from CESU. To meet the emergency requirements during power failure 13 nos of DG set of capacity 11 x 25000 KVA, 1 x 2000 KVA and 1 x 625 KVA will be kept as stand by. The solid waste generated will be 8.45 Tons/Day, which will be disposed as per statutory norms under Public and Private Partnership and the dried sludge from STP will be used as manure in the plantation areas.

Out of the 920.04 Ac. of proposed project area, 100.48 Ac. will come in CRZ-III (A) area i.e within 200 meters from HTL and 143.38 Ac. in CRZ-III (B) area i.e from 200 meters to 500 meters from HTL where certain activities can be done as per the provision of CRZ Notification, 2011. Other activities proposed in the Project will be done beyond the CRZ area.

Part of the proposed project is located in CRZ-CRZ-III (A) & (B) area. As per the report of NCSCM, Chennai (one of the authorised agency by MoEF& CC) some sand dunes are located in the CRZ area of the proposed project area. The Director, Tourism, Govt. of Odisha has submitted an undertaking that "no sand dunes shall be levelled within the CRZ area and No construction shall be taken up within the CRZ area where sand dunes have been reported in the mapping of the NCSCM".

As per the master plan of the propose project only the storm water drainage will be constructed in the CRZ-III (A) area. Hotels and roads will be constructed in CRZ-III (B) area within the norms of CRZ Notification, 2011. All other proposed activities will be done beyond CRZ-III area.

The proposed activates are permissible under the provision of CRZ Notification, 2011 as per:

Para 8(i) –III CRZ-III (A)(iii)(a) "agriculture, horticulture, gardens, pasture, parks, play field, and forestry;)

Para 8(i) –III CRZ-III (A)(iii)(j) "construction of dispensaries, schools, public rain shelter, community toilets, bridges, roads, provision of facilities for water supply, drainage, sewerage, crematoria, cemeteries and electric sub-station which are

required for the local inhabitants may be permitted on a case to case basis by CZMA"

Para 8(i) –III CRZ-III (B)(i) "development of vacant plot in designated areas for construction of hotels or beach resorts for tourists or visitors subject to the conditions as specified in the guidelines at Annexure-III"

It attracts Environmental Clearance as per the EIA Notification, 2006. (as the construction area (built up area) is 916046 sq.m)

These activities require Clearance from MoEF & CC as per the provision of CRZ Notification, 2011 as per Para 4(ii) (a)" those activities not listed in the EIA Notification, 2006".it needs recommendation from OCZMA.

OCZMA may discuss the proposal and if considered, may recommend the proposal to MoEF& CC for CRZ clearance to the aforesaid project under CRZ Notification, 2011.

3. Construction of Building over plot No. 94/400 OF Mouza: BankiMuhan, Puri Town.

Sri Subojit Mukharjee, the project proponent has submitted a proposal for CRZ Clearance for "construction of building over plot no. 94/400 at Chakratirtha Road, Mouza-Bankimuhan, Puri.

The geographical location of the plot is 19^0 48'1.16"N & 85^0 50' 0.91"E. The site is located in the CRZ –II area of Puri.

The land area available for the proposed construction is 2786.56 sq.ft and the construction involves a S+4 building. The construction area used will be 1357.72sq.ft for ground as stilt. About 275 sq.ft of area from the stilt will be used for stair case and lift. The remaining area will open for parking. The construction area of each floor is 1357.72 sq.ft. The 1st, 2nd and 3rd floor with 3 rooms in each floors and 4th floor is with 4 rooms. The total built up area is 5705.88 sq.ft. The FAR of the building is 2.0.

The water requirement during operation phase is 1 KLD, which will met by existing Municipality source. The power requirement is about 10KW, which will be met from Central Electricity Supply Utility (CESU).

As regard to the Environmental Management Plan (EMP), the construction garbage will be used for filling low lying areas and solid waste generated during operational phase will be collected through collection bins and handed over to an authorised solid waste collection agency of the Municipality. The liquid effluent generated will released to the septic tank and ultimately to the municipality sewerage line.

The cost of the project is Rs.1.35Crore.

The proposed site is located on the landward site of the existing road. (as per revenue map of Mouza -Puri town, Unit no. 26, Banki Muhan, sheet no. 2, 1988-89)

The activity is permissible under the Para 8 (i) (II) CRZ-II (i) of CRZ Notification, 2011, "buildings shall be permitted only on the landward side of the existing road or on the landward side of the authorised structures".

The proposed project does not attract Environmental Clearance under EIA Notification, 2006

The proponent has submitted the following documents/maps in respect of the project.

OCZMA may discuss the proposals and if considered, may grant CRZ clearance to the aforesaid projects as per the provision of CRZ Notification, 2011.

D. Issues on CRZ Clearance from previous OCZMA Meetings

1. Improvement of passenger jetty and public rain shelter at 7different sites in different districts in Odisha by the Executive Engineer (Civil) Port & Inland Water Transport, South Division, Berhampur under Directorate of Ports & IWT (Commerce & Transport (Comm.) Dept., Govt. of Odisha.

In 27th meeting of OCZMA held on 31.01.17, the Authority decided to grant clearance from CRZ angle for improvement of passenger jetty and public rain shelter at 7 different sites (Sl.No.1 to 7) as per the provision of CRZ Notification, 2011, subject to the confirmation of DFO,MFD(WL) Rajnagar that the project proposal from. Sl.no.1 to 6 does not come within the Sanctuary/ National Park/ Ecologically Sensitive Zone (ESZ) Area.

The proposal of sl.no.7 (Improvement of passenger jetty and public rain shelter at Sipakuda in Puri district) is free from Sanctuary and Eco-Sensitive Zone area as it is located 17.5 km away from the nearest Nalabana wildlife Sanctuary in Chilika Lagoon.

DFO, MFD (WL) Rajnagar, provided the information for the proposal sl. No.1 to 6 as follows:

Sl.No.1, 2 & 3 at Nimtala, Kasturikana & Kaninali in Bhadrak district are located in Eco-Sensitive Zone (ESZ) area and

Sl.No.-4, 5 & 6 at Upulei, Baradia & Bajarpur in Kendrapada district are located in Bhitarkanika wild life Sanctuary.

OCZMA may take a decision in this regard and clearance from National Board of Wildlife (NBWL) may be sought for according CRZ Clearance of the proposed project.

E. Any other issue with the permission of chair.
